In an August 2017 notification to providers and suppliers, the Centers for the Medicare & Medicaid Services (CMS) communicated changes to its medical review and education strategy. CMS will now concentrate its efforts using a program called "Targeted Probe and Educate" (TPE). Medicare Administrative Contractors (MACs) will identify and selectively audit individual providers with outlier service billing patterns, rather than audit all providers billing the identified service. Ascension Health and Providence St. Joseph Health are in talks to merge and create the nation's largest hospital chain, the Wall Street Journal reported on recently. A merger between St. Louis-based Ascension and Providence out of Renton, Wash., would give the combined not-for-profit entity 191 hospitals in 27 states and annual revenue of \$44.8 billion. The California Department of Managed Health Care (DMHC) has taken enforcement actions including a \$322,500 fine against California Physicians' Service (Blue Shield of California) and a \$135,000 fine against Care 1st Health Plan for failing to identify, timely process, and resolve consumer grievances.
