National ACA marketplace signups dipped a modest 3.7 percent this year

Overall ACA marketplace signups for 2018 dropped by 3.7 percent compared to last year's enrollment period, a new analysis from the Kaiser Family Foundation finds. 11,760,533 people signed up for 2018 health insurance coverage on the ACA individual marketplaces, amid steep reductions in federal funding for outreach and navigators, an enrollment period half as long and a climate of political uncertainty surrounding the law. The Assembly convened hearings in the face of activist outrage with last year's shelving of SB 562, an ambitious bill that would establish a state-funded healthcare system to cover nearly all of Californians' medical costs without requiring premiums or co-pays.
