FDA issues safety alert regarding drug products manufactured by Cantrell Drug Company

The U.S. Food and Drug Administration is alerting healthcare professionals and patients not to use drug products produced by Cantrell Drug Company of Little Rock, Arkansas, including opioids and other drugs intended for sterile injection. FDA investigators observed unsanitary conditions and violations of current Good Manufacturing Practice that could cause the company's drugs to become contaminated or made injurious to health. POSNA reviews opioid prescribing practices in survey

With the overuse and misuse of opioid prescriptions prevalent among the pediatric and teenage population, the Pediatric Orthopaedics Society of North America conducted a survey in 2016 to better understand the prescribing practices of its members. Of the 264 members who responded to seven treatment scenarios with whether they would provide prescriptions for outpatient oral opioids, which opioids and for how long, results showed 75 percent of respondents noted making pain management decisions for their patients. The Centers for Medicare and Medicaid Services announced several new initiatives designed to give patients unfiltered access to their health records and punish organizations that engage in data blocking. The agency also plans to roll out a "complete overhaul" of the Meaningful Use program for hospitals and the Advancing Care Information category of the Quality Payment Program, CMS Administrator Seema Verma told HIMSS18 attendees.
