Changes are Coming to California's Workers' Compensation System

Changes are Coming to California's Workers' Compensation System

1. **DWC will be Updating its Medical Treatment Utilization Schedule (MTUS)** — MTUS treatment guidelines that must be used when treating injured workers. The updated MTUS is based on The Reed Group's ACOEM Treatment Guidelines. Other evidenced-based nationally-recognized treatment guidelines can also be used, if the procedure is not addressed in the MTUS. **Effective: December 1, 2017.**
2. **Implementing a Drug Formulary** — The drug formulary is also based on ACOEM recommendations. If you subscribe to the ACOEM Treatment Guidelines, the drug formulary will be integrated into their treatment guidelines making it easier for physicians to determine which medications are indicated for a procedure/condition according to the latest evidenced-based guidelines. Some medications will be "exempted" from prior authorization under specific

circumstances. Injured workers will still have access to other medications with prior authorization. [COA was successful in adding some pain and anticoagulant medications to the "exempt" list for patients during their peri-operative period \(4 days prior to surgery and 4 days after surgery\).](#)

The Drug Formulary is expected to be effective January 1, 2018.
