California Board of Pharmacy cracking down on prescription forms — controlled substances

IMPORTANT NOTICE — DRUG PRESCRIPTION FORMS

COA members are reporting problems with pharmacies filling prescriptions for controlled substances — Schedule II-V drugs — when their prescription form contains a refill (or no refill "NF") number printed on the pad and that option is circled by the prescriber rather than a box where the prescriber fills in the number of refills. Note — Schedule II drugs cannot be refilled. Technically, circling the number that has been preprinted on the form does not meet the security requirements required by the California Board of Pharmacy. In light of the opioid epidemic, the Pharmacy Board is now enforcing every element of these prescription requirements and fining pharmacies that fill prescriptions from "i

compliant" forms.

If your prescription forms do not include a box where the prescriber enters the number refills, you will need to order new prescription forms that are in compliance. Here is a link to the Pharmacy Board and DOJ approved prescription form printers:

Attorney General Sessions and Acting DEA Administrator Patterson announce new tools to address opioid crisis f

Continuing to follow President Trump's strong leadership on combatting the deadly opioid crisis, Attorney General Sessions today announced new resources and stepped up efforts to address the drug and crisis.

Joined by Acting DEA Administrator Robert Patterson, Attorney General Sessions announced the following efforts during a press conference at the Department of Justice: over \$12 million in grant funding to support law enforcement in combating illegal manufacturing and distribution of methamphetamine, heroin, and prescription opioids; the establishment of a new DEA Field Division in Louisville, Kentucky, which will cover Kentucky, Tennessee, and West Virginia, a move meant to better align DEA enforcement efforts with the Appalachian mountain region; and a directive to all U.S. Attorneys to designate an Opioid Coordinator to work closely with prosecutors, and with other federal, state, tribal, and local law enforcement to coordinate and optimize federal opioid prosecutions in every district. **READ MORE**
