

## State Fines L.A. Care Health Plan \$55 Million in Enforcement Action To Protect Consumers

Department of Managed Healthcare

The California Department of Managed Health Care (DMHC) and Department of Health Care Services (DHCS) have taken action against Local Initiative Health Authority for Los Angeles County (L.A. Care) to protect the plan's members. The two departments' actions against the state's largest Medi-Cal plan include penalties of \$55 million. This consists of a \$35 million penalty from the DMHC and \$20 million sanction from the DHCS.

## Anthem Plans To Change Name, Rebrand

#### Becker's Payer Issue

Anthem, which owns Blue Cross Blue Shield plans in 14 states, plans to change its name to Elevance Health. The company said the new name would better reflect the services it offers beyond health insurance, such as digital, pharmacy,

behavioral, clinical and complex care services. Anthem also said the name change underscores its "commitment to elevating whole health and advancing health beyond healthcare."
